- 275.01 Hereditary hemochromatosis
- 275.02 Hemochromatosis due to repeated red blood cell transfusion
- 275.03 Other Hemochromatosis
- 275.09 Other disorders of iron metabolism

- 276.61 Transfusion associated circulatory overload

Complications of Pregnancy

- 646.30 Recurrent pregnancy loss, unspecified as to episode of care or not applicable
- 646.31 Recurrent pregnancy loss, delivered, with or without mention of antepartum condition
- 646.33 Recurrent pregnancy loss, antepartum condition or complication

Musculoskeletal System

- 724.02 Spinal stenosis, lumbar region, without neurogenic claudication
- 724.03 Spinal stenosis, lumbar region, with neurogenic claudication

Complications of ABO Blood Incompatibility

- 999.60 ABO incompatibility reaction, unspecified
- 999.61 ABO incompatibility with hemolytic transfusion reaction not specified as acute or delayed
- 999.62 ABO incompatibility with acute hemolytic transfusion reaction
- 999.63 ABO incompatibility with delayed hemolytic transfusion reaction
- 999.69 Other ABO incompatibility reaction

Complications of Rh Incompatibility

- 999.70 Rh incompatibility reaction, unspecified
- 999.71 Rh incompatibility with hemolytic transfusion reaction not specified as acute or delayed
- 999.72 Rh incompatibility with acute hemolytic transfusion reaction
- 999.73 Rh incompatibility with delayed hemolytic transfusion reaction
- 999.74 Other Rh incompatibility reaction

Complications of Non ABO Incompatibility

- 999.75 Non-ABO incompatibility reaction, unspecified
- 999.76 Non-ABO incompatibility with hemolytic transfusion reaction not specified as acute or delayed
- 999.77 Non-ABO incompatibility with acute hemolytic transfusion reaction
- 999.78 Non-ABO incompatibility with delayed hemolytic transfusion reaction
- 999.79 Other non-ABO incompatibility reaction

Unspecified Incompatibility Reactions

- 999.80 Transfusion reaction unspecified
- 999.83 Hemolytic transfusion reaction, incompatibility unspecified
- 999.84 Acute hemolytic transfusion reaction, incompatibility unspecified
- 999.85 Delayed hemolytic transfusion reaction, incompatibility unspecified

- V11.4 Personal history of combat and operational stress reaction
- V13.23 Personal history of vaginal dysplasia
- V13.24 Personal history of vulvar dysplasia

- V13.61-V13.69 Personal History of congenital anomalies (corrected)
- V15.53 Personal history of retained foreign body completely removed

- V25.11 Encounter for insertion of intrauterine contraceptive device
- V25.12 Encounter for removal of intrauterine contraceptive device
- V25.13 Encounter for removal and reinsertion of intrauterine contraceptive device

V-Codes, cont.

- V26.35 Testing of male partner of female with recurrent pregnancy loss
- V49.86 Do not resuscitate status
- V49.87 Physical restraint status
- V62.85 Homicidal ideation

- V85.41 Body Mass Index 40.0-44.9, adult
- V85.42 Body Mass Index 45.0-49.9, adult
- V85.43 Body Mass Index 50.0-59.9, adult
- V85.44 Body Mass Index 60.0-69.9, adult
- V85.45 Body Mass Index 70.0 and over, adult

- V88.11 Acquired total absence of pancreas
- V88.12 Acquired partial absence of pancreas

- V90.01-V90.09 Retained radioactive materials
- V90.10-V90.12 Retained metal fragments
- V90.2 Retained plastic fragments
- V90.31-V90.39 Retained organic fragments

Pregnancy Complications - Twins

- V91.00 Twin gestation, unspecified number of placenta, unspecified number of amniotic sacs
- V91.01 Twin gestation, monochorionic /monoamniotic (one placenta, one amniotic sac)
- V91.02 Twin gestation, monochorionic/diamniotic (one placenta, two amniotic sacs)
- V91.03 Twin gestation, dichorionic/ diamniotic (two placenta, two amniotic sacs)
- V91.09 Twin gestation, unable to determine number of placenta and number of amniotic sacs

Pregnancy Complications - Triplets

- V91.10 Triplet gestation, unspecified number of placenta and unspecified number of amniotic sacs
- V91.11 Triplet gestation, with two or more monochorionic fetuses
- V91.12 Triplet gestation, with two or more monoamniotic fetuses
- V91.19 Triplet gestation, unable to determine number of placenta of placenta and amniotic sacs

Pregnancy Complications, Quadruplets

- V91.20 Quadruplet gestation, unspecified number of placenta and unspecified number of amniotic sacs
- V91.21 Quadruplet gestation, with two or more monochorionic fetuses
- V91.22 Quadruplet gestation, with two or more monoamniotic fetuses
- V91.29 Quadruplet gestation, unable to determine number of placenta and number of amniotic sacs

Pregnancy Complications, Other (Unspecified Number)

- V91.90 Other specified multiple gestation, unspecified number of placenta and unspecified number of amniotic sacs
- V91.91 Other specified multiple gestation, with two or more monochorionic fetuses
- V91.92 Other specified multiple gestation, with two or more monoamniotic fetuses
- V91.99 Other specified multiple gestation, unable to determine number of placenta and number of amniotic sacs.

Added Procedures

- 00.60 - Insertion of drug-eluting stent(s) of superficial femoral artery
- 32.27 - Bronchoscopic bronchial thermoplasty, ablation of airway smooth muscle
- 81.88 - Reverse total shoulder replacement
- 4th digit for the carotid sinus stimulation device codes

Additional Procedures

- 39.84 Revision of carotid sinus stimulation lead(s) only
- 39.85 Revision of carotid sinus stimulation pulse generator
- 39.86 Removal carotid sinus stimulation device, total system
- 39.87 Removal of carotid sinus stimulation lead(s) only
- 39.88 Removal of carotid sinus stimulation pulse generator only
- 39.89 Other operations on carotid body/sinus and other vascular bodies

Additional Procedures

- 84.94 Insertion of sternal fixation device w/rigid plates
- 85.55 Fat graft to breast
- 86.87 Fat graft of skin and subcutaneous tissue
- 86.90 Extraction of fat graft or banking

Freezing the Codes

- The last regular, annual updates to both ICD-9-CM and ICD-10 code sets will be made on October 1, 2011.
- On October 1, 2012, there will be only limited code updates to both the ICD-9-CM and ICD-10 code sets to capture new technologies and diseases as required by Section 503(a) of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (Pub. L. 108-173), enacted on December 8, 2003.

Freezing the Codes

- On October 1, 2013, there will be only limited code updates to ICD-10 code sets to capture new technologies and diagnoses as required by section 503(a) of Pub. L. 108-173.
- There will be no updates to ICD-9-CM, as it will no longer be used for reporting.
- On October 1, 2014, regular updates to ICD-10 will begin.
